WHEREAS, The City of San Diego is the owner of a portion of Pueblo Lot 1255 of the Pueblo Lands of San Diego, according to Map by James Pascoe in 1870, a copy of which was filed November 14, 1921 and known as Miscellaneous Map No. 36; and

WHEREAS, the Property Director has requested that the City grant to ROBERT A. SCHAFFER and IRENE S. SCHAFFER, owners of the adjoining property, City's interest in and to said property; and

WHEREAS, said land has been determined to be surplus property by the Property Department of said City; and

WHEREAS, the City desires to negotiate the sale of said land to ROBERT A. SCHAFFER and IRENE S. SCHAFFER, husband and wife, under the provisions of Section 22.0902 (e) of the San Diego Municipal Code which permit the sale of real property belonging to The City of San Diego by negotiaiton; and

WHEREAS, the sale of such an interest in real property as this may reasonably be accomplished only by negotiation; and

WHEREAS, it has been determined by a staff appraisal that the value of the property is the sum of Five Thousand, Three Hundred Five Dollars (\$5,305); and

WHEREAS, no real estate broker's commission shall be paid and all costs relating to the sale shall be borne by the applicant; and

WHEREAS, the sale of the aforementioned property is consistent with the public interest; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 2. That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a grant deed, the form of which is on file in the office of the City Clerk as Document No. 756606

 granting to ROBERT A. SCHAFFER and IRENE S. SCHAFFER, husband and wife as joint tenants, portion of Pueblo Lot 1255 of the Pueblo Lands of San Diego, as more particularly described in said form of grant deed, provided that Grantee shall file a parcel map incorporating the property with his ownership creating a single lot.
- 3. That no broker's commission shall be paid by City on the herein described sale and all costs relating to the sale shall be borne by the grantee.
- 4. That the requirements of Council Policy 700-30, as to advertising and public notice, are hereby waived.
 - 5. That the City Clerk of said City is hereby authorized

and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
