WHEREAS, The City of San Diego, California has entered into a contract with the U. S. Department of Housing and Urban Development (HUD) to carry out, within the City of San Diego, a housing and community development program; and

WHEREAS, the successful implementation of community improvement projects in the Harbor 101/Barrio-Logan Community Planning Area requires the use of Block Grant funds in the estimated amount of \$100,000 for the purpose of designing feasible plans; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the scope of services, work program and budget for the Barrio-Logan planning study as set forth in document on file in the office of the City Clerk as Document No. 756615, be and the same are hereby approved.

2. That the City Auditor and Comptroller is hereby authorized to transfer the sum of \$100,000 from Block Grant Fund 290 to Redevelopment Fund 9837 for the purpose of planning community improvement projects in the Barrio-Logan Community Planning Area.

3. Said transfer of funds shall be considered as an advance to be repaid from future tax increments or other appropriate sources as such funds become available.
