That the expenditure of \$133,000 from Capital Outlay Fund 245; \$38,423.49 from Park Service District Fund 11741; \$10,815.00 from Park Service District Fund 16741 and \$16,761.51 from Capital Outlay Fund Unallocated Reserve, for a total of \$199,000.00, to be used for acquisition costs of the above property and related expenses, is hereby approved and authorized.

That the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
