APPROVING MAP OF DE LA FUENTE INDUSTRIAL PARK SUBDIVISION


BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by FRANK M. POWELL, Registered Civil Engineer, and entitled "DE LA FUENTE INDUSTRIAL PARK Being a subdivision of portions of Lots 21, 22 and 27 of Highlands, according to Map thereof No. 284, filed in the Office of the County Recorder of San Diego County, March 16, 1884, all being in The City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following, to-wit: Vickers Street and a portion of Kearny Mesa Road, for public purposes and said street and portion of street are hereby declared to be a public street and portion of a public street and dedicated to the public use.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public street and portion of public street are accepted on behalf of the public as heretofore stated.

Said City Clerk is hereby directed to transmit said map to the
Clerk of the Board of Supervisors of the County of San Diego,
California.
