

RESOLUTION No. 216767


Adopted on SEP 15 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of City, an agreement with CLARENCE E. MINNERLY for the construction of improvements on La Cuenta Drive, within the limits of VILLA MAJORCA UNIT NO. 3 subdivision, and to provide for reimbursement by the City out of Capital Outlay Fund 245 in an amount not to exceed \$5,514.36, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 756659.

BE IT FURTHER RESOLVED, that the expenditure of \$5,514.36 from Capital Outlay Fund 245 (CIP 58-001 (7)), for the above stated services, is hereby authorized and approved.
