

RESOLUTION No. 216775


Adopted on SEP 15 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of ROBERT ESTUDILLO, an individual, executed in favor of The City of San Diego, bearing date of July 23, 1976, conveying to said City an easement and right of way for a public street and incidents thereto, over, under, upon, along and across a portion of Lot A170 of Addition No. 1 to San Ysidro, according to Map thereof No. 1194 filed in the office of the County Recorder of San Diego County, July 13, 1909, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named BOLTON HALL ROAD.

That the City Clerk is hereby authorized and directed to file said deed, after acceptance by the City Manager, and a certified copy of this resolution for record in the office of the County Recorder of San Diego County.
