

RESOLUTION NO. 216797

WHEREAS, MEXICOACH, INC. has applied to the City Council for five Certificates of Public Convenience and Necessity to operate automobiles for hire within the limits of the City of San Diego; and

WHEREAS, pursuant to Section 72.0204 of the Municipal Code, the City Manager has caused an investigation to be made and has reported his findings in writing to this Council, which report indicates:

(a) The applicant will offer year-round per capita and group tours to Tijuana, Mexico. There seems to be public demand for this type of service. The San Diego Convention and Visitors' Bureau border crossing projection for 1976 is 37,000,000 or 3.8% above the 1975 figure of 35,651,925.

(b) There are four existing certificated sightseeing operators in the City of San Diego. Of these, Mexcursions, Inc. with ten certificates and Multilingual Guide Service with two certificates provide services similar to those proposed by Mexicoach.

(c) The company appears to be financially sound.

(d) The vehicles to be used are 41-45 passenger buses.

(e) The proposed service should not significantly add to traffic congestion or parking problems in the City.

(f) The proposed service should not increase hazards to the public.

(g) Company references have been satisfactorily checked.


WHEREAS, the Council this date, after a public hearing, has found the contents of the City Manager's report to be correct and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That Mexicocoach, Inc., having filed an application for five Certificates of Public Convenience and Necessity to operate automobiles for hire pursuant to the provisions of Section 72.0202 of the San Diego Municipal Code, and the City Manager having conducted the required investigation, five Certificates of Public Convenience and Necessity are hereby granted to Mexicocoach, Inc. to operate as sight-seeing vehicles the vehicles specified in the application, subject to compliance with all provisions of the San Diego Municipal Code.
