Department of Commerce for financial assistance under Title I of the Public Works Employment Act of 1976, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. **756714**.

BE IT FURTHER RESOLVED, that the expenditure of \$20,000 is hereby authorized out of General Fund 100 (Unallocated Reserve) of The City of San Diego, solely and exclusively for the purpose of providing funds for the above-referenced services and related costs.
