
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bid of Maintenance Engineers is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing **COMPLETE LANDSCAPE MAINTENANCE OF THIRTY-TWO (32) SELECTED SITES** as may be required for a period of twelve (12) months beginning September 1, 1976 through August 31, 1977, at a cost of \$5,000.00 per month for a total cost of \$60,000.00; terms 2% 20 days, with an option to renew the contract for two (2) additional one (1) year periods.
