APPROVING MAP OF JUEGOS DE JUAN TENNIS CLUB SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by O. B. SHOLDERS, Registered Civil Engineer, entitled "JUEGOS DE JUAN TENNIS CLUB Being a subdivision of Lot 58 of Allied Gardens Addition, according to Official Plat thereof No. 3206, filed in the office of the County Recorder of San Diego County, March 25, 1955, and a portion of Lot 67 of Rancho Mission of San Diego, according to Partition Map thereof, made in the action entitled "Juan M. Luco, et al. vs. The Commercial Bank of San Diego, et al." under Superior Court Case No. 348, on file in the office of the County Clerk of San Diego County, all being in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.



said Council has approved said subdivision map; and that those certain abutters' rights of access as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
