
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the expenditure of not to exceed \$1,800 from Gas Tax Fund 220 for acquisition of the above described property and related expenses is hereby authorized and approved.

That the City Clerk is hereby directed to deliver said deed after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
