WHEREAS, Ordinance No. 9332 (New Series) established a Photogrammetric Revolving Fund of fifteen thousand dollars for the purpose of providing funds for photogrammetric aerial survey services; and

WHEREAS, Resolution No. 216154 instructed the City Manager to expedite a design study of Crescent Bay; and

WHEREAS, an aerial survey of Crescent Bay has been obtained for use in said design study at a cost of \$3,713.50; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Auditor and Comptroller be and he is hereby authorized to expend the sum of \$3,713.50 from Capital Outlay Fund 245 solely and exclusively to reimburse the Aerial Survey Ordinance, No. 9332 (New Series) for the cost of aerial survey services for Crescent Bay in Mission Bay Park.
