

1. That the bid of \$125,008.00 by Long, Marker & Howley Construction Co., a corporation, for the CONSTRUCTION OF THE OTAY MESA SEWER AND SAN YSIDRO SCHOOL DISTRICT WATER MAIN in the City of San Diego, California is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 756042.
2. That the expenditure of \$164,575.00 is hereby authorized out of the Sewer Revenue Fund (Fund 506); that the expenditure of \$28,500.00 is hereby authorized out of the Water Revenue Fund (Fund 502) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF THE OTAY MESA SEWER AND SAN YSIDRO SCHOOL DISTRICT WATER MAIN in the City of San Diego, and related costs.
