

**RESOLUTION No. 216852**

Adopted on SEP 28 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the verbal appeals from the Street Superintendent's Assessment No. 3900, made to cover the costs and expenses of the work of the installation of sewer main, laterals, and appurtenances in SPALDING PLACE, from Georgia Street west to Alley in Block 24, University Heights, under Resolution of Intention No. 215116, adopted January 21, 1976, be, and they are hereby overruled and denied and all other appeals, written or verbal, are hereby overruled and denied.

The Street Superintendent's Assessment No. 3900 is hereby confirmed and approved, and the Street Superintendent of said City is hereby authorized and directed to attach his warrant thereto and issue the same in the manner and form provided by law. Said warrant shall bear date of this order. The Street Superintendent of said City shall record in the office of said Street Superintendent said warrant, diagram and assessment. The City Clerk shall cause to be filed in the office of the County Recorder a copy of the assessment diagram and shall record a notice of assessment, as provided for in Section 3114 of the California Streets and Highways Code.
