BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, two agreements with RICK ENGINEERING COMPANY for professional engineering services for design of various proposed improvements to City facilities included in grant applications with the Economic Development Administration, U. S. Department of Commerce for financial assistance under Title I of the Public Works Employment Act of 1976, under the terms and conditions set forth in the form of agreements on file in the office of the City Clerk as Documents No. 756804 and No. 756805.

BE IT FURTHER RESOLVED, that since the above two agreements are contingent upon federal approval and federal funding, the City Manager is directed to withhold approval to start work as specified therein until such time as the Economic Development Administration grants approval to proceed with the expenditure of 1976 Public Works Employment Act funds.

BE IT FURTHER RESOLVED, that should the Economic Development Administration not grant approval for the projects which are the subject of the two agreements above, the City Manager is directed to declare the agreements of no effect pursuant to the terms of the agreements.
