BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with WALTER LEWIS, LANDSCAPE ARCHITECT, for professional architectural services for design of various proposed improvements to City facilities included in grant applications with the Economic Development Administration, U. S. Department of Commerce for financial assistance under Title I of the Public Works Employment Act of 1976, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 756807.

BE IT FURTHER RESOLVED, that Capital Improvement Project (C.I.P.) Nos. 38-009 and 38-013 be and they are hereby merged into and identified as C.I.P. No. 38-011.

BE IT FURTHER RESOLVED, that funds previously allocated said C.I.P. Project Nos. 38-009 and 38-013 be transferred into C.I.P. Project No. 38-011 for a new allocated amount of \$17,000 to be expended for said project.

BE IT FURTHER RESOLVED, that the sum of \$3,000 be transferred within the General Fund 100 from the Unallocated Reserve (53.30) to the Allocated Reserve (53.20) to be used solely and exclusively for the purpose of providing additional funds for the above referenced architectural services.
