S. Department of Commerce for financial assistance under Title I of the Public Works Employment Act of 1976, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 756817.

BE IT FURTHER RESOLVED, that the transfer of \$2,500 is hereby authorized within General Fund 100 from Unallocated Reserve (53.30) to the Allocated Reserve (53.20) of The City of San Diego, solely and exclusively for the purpose of providing funds for the above-referenced services.
