S. Department of Commerce for financial assistance under Title I of the Public Works Employment Act of 1976, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 756895.

BE IT FURTHER RESOLVED, that the transfer of \$10,000 is hereby authorized within General Fund 100 from Unallocated Reserve (53.30) to the Allocated Reserve (53.20) of The City of San Diego to be used solely and exclusively for expenditure of funds for the above-referenced services.
