RESOLUTION NO. 216861 SEP 29 1976

WHEREAS, at the Council meeting of April 14, 1976, the City Manager was directed to apply for an appropriate coastal permit to allow for the removal of the docks in the Crescent Bay area of Mission Bay; and

WHEREAS, on June 9, 1976, the City Council approved the recommendations of the Park and Recreation Board which included the immediate demolition of certain docks and the temporary retention of other docks and the Council further directed that all the docks must be removed by June 8, 1978; and


WHEREAS, the City Manager applied for a coastal permit pursuant to the June 9 resolution of the City Council and further requested that the coastal permit allow for the removal of certain fences which block public access to the beach and for the approval of placing waste receptacles and fire rings in appropriate areas on the beach; and

WHEREAS, at its meeting of September 24, 1976 the San Diego Regional Commission denied the permit application; and

WHEREAS, in furtherance of the objectives of the California Coastal Zone Conservation Act it is necessary that the permit be obtained in order that the public have maximum access to the beach area; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
that the City Manager is hereby authorized and directed to appeal
the decision of the San Diego Coast Regional Commission to the
California Coastal Zone Conservation Commission.
