1. That the bid of \$54,587.50 by Neil Di Lello, an individual, dba N.D.L. Cement Contractors, for the CONSTRUCTION OF PEDESTRIAN RAMPS FOR THE HANDICAPPED - CONTRACT NO. 3 in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 756022.
2. That the expenditure of \$68,100.00 is hereby authorized out of the First Year Block Grant Fund (Fund 2910) and that the expenditure of \$5,000.00 is hereby authorized out of the Capital Outlay Fund (Fund 245) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF PEDESTRIAN RAMPS FOR THE HANDICAPPED - CONTRACT NO. 3 in the City of San Diego, and related costs.
