
Adopted on SEP 29 1976

That the acceptance by the City Manager of that deed of ROBERT H. CLARNO, JR., RODERICK L. BROTHERTON, ROY E. WINCHELL and MICHAEL B. HAYS, as tenants in common, executed in favor of The City of San Diego, bearing date of August 26, 1976, conveying to said City for public purposes portions of Lots 1 and 2 in Block 1 of Harris Palm Tract, according to Map thereof No. 1473, filed in the Office of the County Recorder of San Diego County, September 5, 1912, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street and the same is hereby named PALM AVENUE.

That the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
