

RESOLUTION No. 216881

Adopted on SEP 29 1976


BE IT RESOLVED, by the Council of The City of San Diego as follows:

That approximately 18.8 acres of City-owned land located east of Margerum Avenue (Margerum Avenue Park Site - Park District #383), are hereby designated as a neighborhood park and youth sports activity area.

BE IT FURTHER RESOLVED, that Study Plan "B", a copy of which plan is on file in the office of the City Clerk as Document No. 756853, is hereby accepted as the preferred improvement plan for the park.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and directed to proceed with the development of a proposed grading plan for the park site and to process the documents necessary to obtain environmental review of the proposed park improvements.
