

RESOLUTION No. 216889 R. 77-415

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That Gray, Cary, Ames & Frye, attorneys at law, be appointed as special bond counsel in connection with the proceedings under the Municipal Improvement Act of 1913, and the San Diego Park District Procedural Ordinance of 1969, for Crest Canyon Park Reserve District (San Diego Park District No. 17), pursuant to the terms and conditions set forth in the letter dated July 28, 1976, on file in the office of the City Clerk as Document No. 756854.

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$7,600 from Environmental Growth Fund 2505 is hereby authorized, solely and exclusively, for payment of the above stated services in the event the proposed proceedings fail to materialize or are abandoned prior to the issuance of bonds.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$7,600 from CIP 92505 (Environmental Growth Fund Unallocated Reserve) to CIP 20006 (Park Reserve) for the sole and exclusive purpose of providing funds for the above services.
