BE IT RESOLVED, by the Council of The City of San Diego as follows:



That the acceptance by the City Manager of that deed of the STATE OF CALIFORNIA, acting by and through its Director of Transportation, executed in favor of The City of San Diego, conveying to said City for public purposes a portion of Lot 47 of Rancho Mission (R/W DD-21486-01-01), as more particularly described in said deed, be and the same is hereby approved.

2. That the acceptance by the City Manager of that deed of the STATE OF CALIFORNIA, acting by and through its Director of Transportaion, executed in favor of The City of San Diego, conveying to said City for public purposes a portion of Lot 47 of Rancho Mission (R/W DD-21487-02-01), as more particularly described in said deed, be and the same is hereby approved.

3. That the City Auditor and Comptroller is hereby authorized and directed to transfer the sum of \$56,600 from C.I.P. 92-505 Environmental Growth Unallocated Reserve to C.I.P. 20-006, Park Reserve.

4. That the City Auditor and Comptroller is hereby authorized to expend the sum of not to exceed \$56,600 from Environmental Growth Fund 2505, C.I.P. 20-006 to be used solely and exclusively for acquisition purposes of the above described parcels of land.
