
Adopted on OCT 6 1976

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with ASSOCIATED ENGINEERS, a California corporation, to provide professional engineering services for design of NORTH PARK DRAIN, PHASE 1 improvements, between El Cajon Boulevard at 30th Street and Polk Avenue at Interstate 805, in the City of San Diego, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 756929.

BE IT FURTHER RESOLVED, that the expenditure of \$21,000 is hereby authorized out of Storm Drain Bond Fund 727 of The City of San Diego, solely and exclusively for the purpose of providing funds for the above-referenced services and related costs.
