BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to expend the sums of \$5,000 from Capital Outlay Fund 245; \$5,000 from Park Service District Fund 12141; \$5,000 from Park Service District Fund 12145; \$1,000 from Park Service District Fund 11403; and \$12,000 from Fund 100 (Park and Recreation Department Budget) for said purpose and related costs.
