BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to transfer within the 244 Fund the sum of \$7,200 from CIP Project No. 33-021 (Fire Station No. 12) to CIP Project No. 33-029 (Fire Station No. 13; \$3,400) and CIP Project No. 33-027 (Fire Station No. 39; \$3,800) to be used solely and exclusively for the purpose of providing funds for the above-referenced services.
