1. That the bid of \$21,397.00 by ORGANIZED CONSTRUCTION, INC., a corporation, for the CONSTRUCTION OF MORRELL STREET DRAIN in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 755899.

2. That the expenditure of \$13,000.00 is hereby authorized out of the Flood Control and Storm Drain Bond Fund (Fund 727); and that the expenditure of \$16,000.00 is hereby authorized out of the Gas Tax Unallocated Reserve (Fund 219) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF MORRELL STREET DRAIN in the City of San Diego and related costs.
