

RESOLUTION NO. 216945

WHEREAS, Resolution No. 210916 adopted by the Council of The City of San Diego on June 20, 1974, established green fees to be charged on the municipal golf courses; and

WHEREAS, said fee schedule, established in Resolution No. 210916 included a surcharge that was to be placed into a special fund and used to partially reimburse Capital Outlay Fund 245 for the expenses necessary to renovate the greens at Torrey Pines Golf Course; and

WHEREAS, the greens renovation program has been completed and all charges against the program have been paid at a total cost of \$471,099; and

WHEREAS, in June 1975 the Torrey Pines Men's Club petitioned the Park and Recreation Director to form a committee that would study the possible extension of the surcharge to make additional capital improvements to the course; and

WHEREAS, a committee composed of representatives from Torrey Pines Men's and Women's Clubs, interested golfers, lessees, Junior Golf Association, Andy Williams Open, and staff have discussed the surcharge extension and unanimously agreed that needed improvements could be realized more readily by matching surcharge monies with Capital Improvement Funds; and

WHEREAS, several projects have been recommended that will insure the continued orderly improvement of the course; and

WHEREAS, automation of the irrigation system has been selected as the most vital correction to be made at this time, with an estimated cost of \$500,000; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


That Resolution No. 210916 adopted by the Council of The City of San Diego on June 20, 1974, be amended to authorize the Park and Recreation Director to continue collecting surcharge monies set forth therein.

BE IT FURTHER RESOLVED, that the City Auditor be and he is hereby directed to continue depositing said surcharge monies into Special Fund 248 to be used to partially reimburse Capital Outlay Fund 245 for the expenses necessary to automate the irrigation system at Torrey Pines Golf Course and that all unexpended funds in Fund 248 be reallocated for the same purpose.

BE IT FURTHER RESOLVED, that this resolution shall become effective on October 1, 1976.
