**RESOLUTION No. 216948**

Adopted on OCT 6 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows:

WHEREAS, The Vietnamese Alliance Association (herein called "Association") is conducting a Children's Harvest Festival on October 23, 1976 in the Balboa Park Club, and

WHEREAS, the purpose of the festival is to bring together during this annual celebration the Vietnamese people and the citizens of the City of San Diego; and

WHEREAS, the most important function of this festival will be to assist the Vietnamese children to retain their customs, language and culture; and

WHEREAS, the normal rental fee for use of said club is \$325.00 per day; and


