- l. That the City Manager or his authorized representative be and he is hereby authorized and empowered to submit, for and on behalf of said City, a grant application to pave and otherwise improve MARKET STREET, from 47th Street to Euclid Avenue, a project which is in the City of San Diego, including appropriate certifications and assurances with the Economic Development Administration (EDA), U. S. Department of Commerce for financial assistance under Title I of the Public Works Employment Act of 1976 and to transcribe the contents of the applications and supportive certifications and assurances onto applicable forms as prescribed and directed by EDA at such time as said forms are made available to The City of San Diego by EDA and upon approval by EDA, authorizing the City Manager to execute said grant applications.
- 2. That Resolution of Intention No. 216482, adopted by this Council on July 28, 1976, which declared an intention to order certain work and improvements to improve MARKET STREET, from 47th Street to Euclid Avenue, is hereby revoked and the assessment district proposed therein is specifically abandoned.
- 3. That funds in the amount of \$290,000 previously allocated from Gas Tax Fund CIP No. 52-063.4 be transferred into the Gas Tax Fund Unallocated Reserve, CIP No. 90-220.
