WHEREAS, said agreement provides that District shall fund all architectural planning costs and construction costs associated with the pools, exclusive of public bath and dressing facilities; and

WHEREAS, said agreement provides that City shall fund the planning and construction of necessary public bath and dressing facilities in the same or subsequent contract at a total cost not to exceed \$400,000; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the expenditure of \$400,000 from Capital Outlay
Fund 245 is hereby authorized solely and exclusively for

City's share of construction costs of two swimming pools for Project I, Community/School Recreation Swimming Pools at Two Junior High Schools located contiguous to Marston Junior High School and Lewis Junior High School.
