

RESOLUTION NO. 216977

VACATION OF YUMA STREET, BETWEEN COLUSA STREET
AND DONAHUE STREET AND BETWEEN BLOCKS 8 AND 9,
BAY VIEW ADDITION, MAP 271.

WHEREAS, it is proposed that YUMA STREET, between Colusa Street and Donahue Street and between Blocks 8 and 9, Bay View Addition, Map 271, be vacated; and

WHEREAS, there is no present or prospective use for the street, either for the public street system for which the right-of-way was originally acquired or for any other public use of a like nature that can be anticipated; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation or abandonment is not inconsistent with the General Plan or an approved Community Plan; and


WHEREAS, the public street system for which the right-of-way was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that YUMA STREET, between Colusa Street and Donahue Street and between Blocks 8 and 9, Bay View Addition, Map 271, as more particularly referred to in Resolution of Intention No. 216723 is unnecessary for present or prospective public street purposes.

BE IT FURTHER RESOLVED, that YUMA STREET, between Colusa Street and Donahue Street and between Blocks 8 and 9, Bay View Addition, Map 271, as more particularly shown on Map No. 13765-B, on file in the office of the City Clerk as Document No. 756607, which said map is attached hereto and made a part hereof, be and the same is hereby ordered vacated.

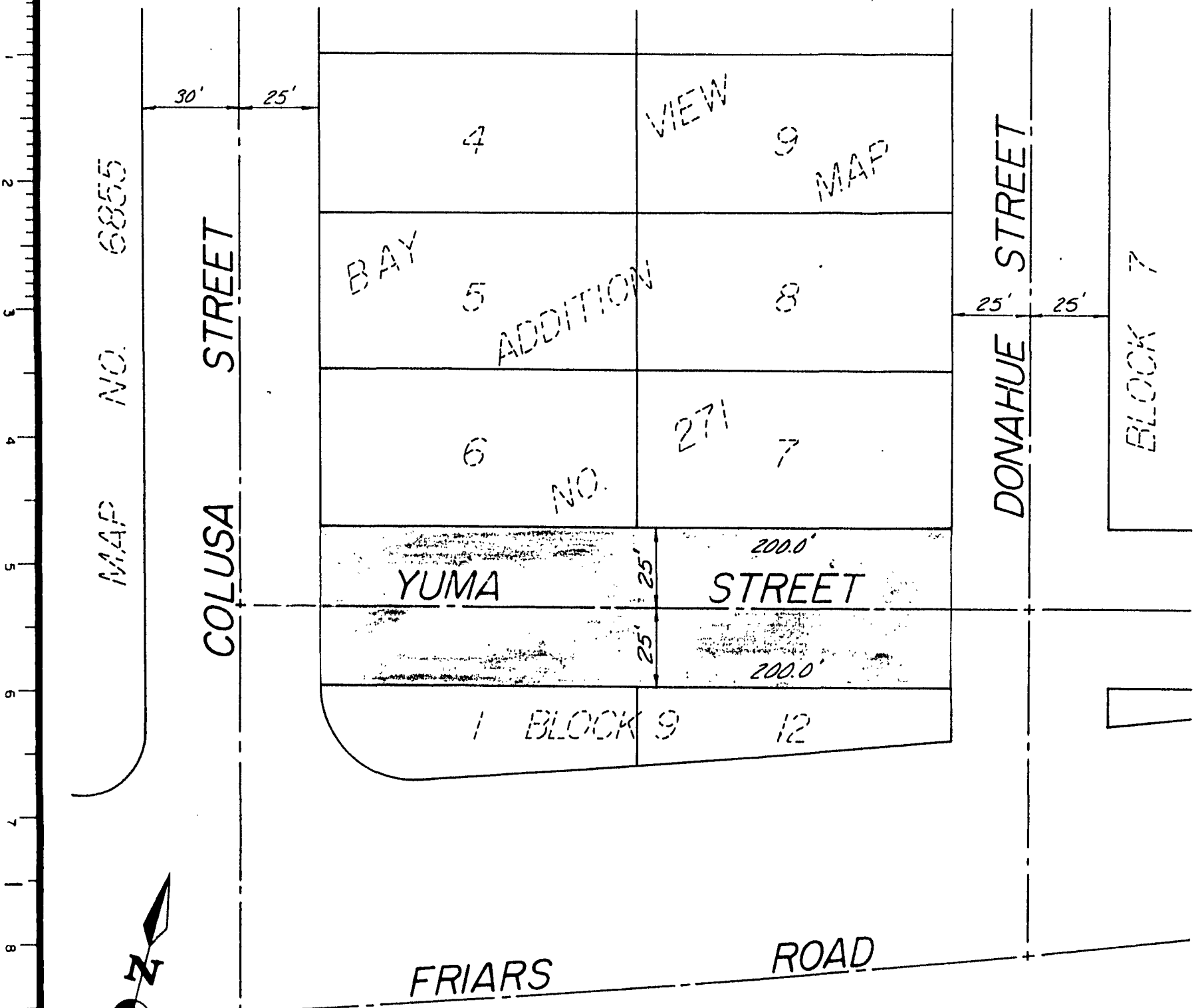

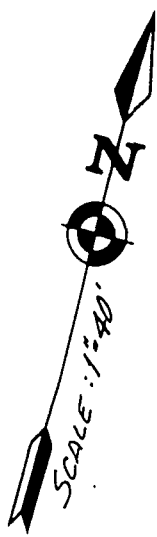


COLUSA STREET
