

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with THE CHRISTIANA COMPANIES, INC., a Delaware corporation, for the construction of improvements on Santo Road for a distance of approximately 810 feet, Clairemont Mesa Boulevard for a distance of approximately 2034 feet, Tierrasanta Boulevard for a distance of approximately 943 feet and oversizing of culvert on Santo Road, within the limits of VILLA MONSERATE UNIT NO. 1 subdivision, and to provide for reimbursement by the City out of Capital Outlay Fund 245, in an amount not to exceed \$46,631.43, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. **757116**.
