RESOLUTION OF INTENTION INITIATING PROCEEDINGS FOR
THE ESTABLISHMENT OF THE MARKET STREET LIGHTING
DISTRICT.

WHEREAS, pursuant to Sections 65.0201 et seq. of the San Diego Municipal Code and Section 22500 et seq. of the California Streets and Highways Code, The City of San Diego proposes the formation of the MARKET STREET LIGHTING DISTRICT; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the public interest, convenience and necessity require and it is the intention of this Council to order the formation and establishment of a maintenance district pursuant to the San Diego Maintenance District Procedural Ordinance of 1975 (commencing with Section 65.0201 et seq., San Diego Municipal Code) for the maintenance of public facilities within the boundaries of the district to be known as MARKET STREET LIGHTING DISTRICT. The maintenance shall include but is not limited to the supplying of energy to street lights, replacement of lamps and glassware, and periodic cleaning and painting of standards.


2. The proposed district is generally described as follows:

The abutting property and right-of-way of Market Street, between 41st Street and Denby Street, as shown on the map on file in the office of the City Clerk as Document No. 757132,

3. It is proposed that the maintenance shall be performed from the date of the formation of the district until June 30, 1977.

4. That the City Engineer is hereby directed to prepare and file a report in accordance with Section 22565 et seq. of the Streets and Highways Code of the State of California.
