

RESOLUTION No. 217011


Adopted on OCT 27 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of WILLIAM W. NETOLICKY, a widower, executed in favor of The City of San Diego, bearing date of September 10, 1976, conveying to said City the permanent easement and right of way for a public street and incidents thereto, over, under, upon, along and across a portion of Lots 6 and 7 in Block 8 of Sunny Slope Addition to Encanto Heights according to Map there of No. 1135 filed in the Office of the County Recorder of San Diego County on June 4, 1908, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named MADERA STREET.

That the City Clerk is hereby authorized and directed to file said deed, after acceptance by the City Manager, and a certified copy of this resolution for record in the office of the County Recorder of San Diego County.
