
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of the BANK OF CALIFORNIA, Trustee of the estate of Esther Pearl Markham, executed in favor of The City of San Diego, bearing date of August 27, 1976, conveying to said City for public purposes Lots 9 through 18 inclusive, Lots 26 and 25 and Lots 31 through 40 inclusive of Block 12, Paradise Valley Heights, according to Map thereof No. 166 filed in the Office of the County Recorder, as more particularly described in said deed, be and the same is hereby approved.

That the expenditure of \$8,600 from Capital Outlay Fund 245 is hereby authorized, supplementing Resolution No. 177648, adopted October 24, 1963, in said amount.

That the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
