
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of THE HOUSING GROUP, a California corporation, executed in favor of The City of San Diego, bearing date of July 22, 1976, conveying to said City for public purposes Lot 6 and a portion of Lot 5 of Scripps Village Center Unit No. 3, Map No. 7085, filed in the San Diego County Recorder's office on October 18, 1971, as more particularly described in said deed, is hereby approved.

That the expenditure of not to exceed \$260,000 from Special Assessment Fund 3719 to cover all acquisition costs for the above described property is hereby authorized and approved.

That the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
