WHEREAS, Resolution No. 212235, adopted December 19, 1974 by the Council of The City of San Diego, authorized the City Manager to execute for and on behalf of said City an agreement with TUCKER & KATER LANDSCAPE ARCHITECTS for landscape architectural services required for the design of the Southeast San Diego Sports Field, the original of which agreement is on file in the office of the City Clerk as Document No. 749861; and

WHEREAS, Resolution No. 214822, adopted December 10, 1975 by the Council of The City of San Diego, authorized the City Manager to execute for and on behalf of said City the First Amendment to the Agreement with TUCKER & KATER LANDSCAPE ARCHITECTS, the original of which First Amendment is on file in the office of the City Clerk as Document No. 753744; and

WHEREAS, this Second Amendment to the Agreement with TUCKER & KATER LANDSCAPE ARCHITECTS will provide construction documents for Phase III development of the Southeast San Diego Sports Field, including fine grade, irrigation systems, landscaping, area lighting, picnic facilities, and tiny tots play equipment; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City,

a Second Amendment to Agreement with TUCKER & KATER LANDSCAPE ARCHITECTS for landscape architectural services required for the design of the Southeast San Diego Sports Field, under the terms and conditions set forth in the form of Second Amendment to Agreement on file in the office of the City Clerk as Document No. 757147 .

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to expend the sum of \$12,500 from Capital Outlay Fund 245 of The City of San Diego, solely and exclusively for the purpose of providing funds for design and related expenses and supplementing Resolution No. 212235 in this amount.
