BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the expenditure of \$79,500 from Capital Outlay Fund 245 of The City of San Diego is hereby authorized solely and exclusively for providing funds for the construction of certain public improvements in the radio communications systems of the Police and Fire Departments and the Lifeguard Service by and through CIP Nos. 37-087.1, 37-095.1 and 37-077.1.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to do by City Forces all necessary work in conjunction with the above referenced project, pursuant to the recommendations of the City Manager and the submission of his estimates indicating that said work can be done more economically by City Forces than if let by contract and the need of close coordination with operating departments to prevent disruption of vital police, fire and lifeguard communications.
