
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered, for and on behalf of said City, to enter into negotiations for an agreement with the County of San Diego for the purpose of funding one-third of the Releasee Aid Program contingent upon the County of San Diego funding the remaining two-thirds of the program.

BE IT FURTHER RESOLVED, that the allocation of up to and not exceeding \$26,666 in unexpended fiscal year 1976 Revenue Sharing Funds (Fund #265) of The City of San Diego, be and it is hereby authorized for the purpose of funding one-third of the Releasee Aid Program cost to be used in the event that the County of San Diego agrees to fund two-thirds of said Program.
