RESOLUTION No. 217030

Adopted on OCT 27 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That The City of San Diego hereby consents to the establishment of a portion of MAST BOULEVARD, between Mission Gorge Road and 1,000 feet northeasterly of Rumson Drive, lying within the City limits, as a part of the County Highway for purposes of right of way acquisition, construction, maintenance, improvement and repair, as described in Resolution No. 16 of the Board of Supervisors of San Diego County, passed and adopted on April 27, 1976, which resolution is affixed hereto as EXHIBIT A.

BE IT FURTHER RESOLVED, that this resolution is adopted subject to the condition that it is understood that it is the intent of the County to use the passable traveled way created by the improvement herein described, and lying northerly of Carlton Oaks Drive, for the purpose of providing controlled access for vehicles entering and leaving the Sycamore Canyon Sanitary Landfill, which lies approximately one and one-half miles northerly from the intersection of Carlton Oaks Drive and Mast Boulevard.

RESOLUTION DECLARING MAST BOULEVARD
WITHIN THE CITY LIMITS OF SAN DIEGO
TO BE A COUNTY HIGHWAY

ON MOTION of Supervisor Conde, seconded by Supervisor Bates,
the Board of Supervisors of the County of San Diego, by not less than a four-
fifths vote hereby adopts the following resolution:

WHEREAS, the County of San Diego contemplates the improvement of a future
street known as Mast Boulevard, from Mission Gorge Road northerly to a point
1000 feet northeast of Rumson Drive, a distance of 0.9 mile, all in accordance
with plans to be prepared by the County Engineer of the County of San Diego; and

WHEREAS, said street is within the city limits of the City of San Diego; and

WHEREAS, in the opinion of this Board the construction of said street lying
within the city limits of the City of San Diego is of general County interest
and will be of general benefit to the County of San Diego; and

WHEREAS, under the provisions of the Streets and Highways Code of the State
of California, Section 1700 to 1704, both inclusive, by at least a four-fifths
vote of the members declare any highway lying in whole or in part within a city
to be a County Highway, and upon the taking effect of a city resolution con-
taining the consent of the city thereto, said highway becomes a County Highway
with respect to acquisition of right-of-way, construction, maintenance, improve-
ment and repair;

NOW THEREFORE IT IS RESOLVED, ORDERED AND DECLARED that the construction
and improvement of Mast Boulevard from Mission Gorge Road to Rumson Drive, a
distance of 0.9 mile, lying within the city limits of the City of San Diego is
of general interest to the County of San Diego.
