That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the SAN DIEGO/LEON SISTER CITY SOCIETY, a bona fide community organization, to sponsor and coordinate attendance of the Asociación de Charros de San Ysidro at the National Congress of Charros Associations of Mexico in Leon, Guanajuato, Mexico from November 1 through November 10, 1976, pursuant to the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 757108.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to transfer within the 224 Fund the sum of \$1,000 from the Contingency Reserve (52.99) to the San Diego/Leon Sister City Society, Inc. (52.14), said funds to be used solely and exclusively for providing financial support for the above authorized activity.
