public street purposes.

Park, Map 352, as more particularly shown on Map No. 13759-B, on file in the office of the City Clerk as Document No. 756681, which said map is attached hereto and made a part hereof, be and the same is hereby ordered vacated.

BE IT FURTHER RESOLVED, that the City Clerk shall cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.


