A RESOLUTION OF THE CITY COUNCIL AMENDING THE CAPITAL IMPROVEMENTS PROGRAM BY AMENDING DOCUMENT NO. 754397, AS AMENDED, TO PROVIDE FUNDS FOR C. I. P. PROJECT NO. 29-351, ACQUISITION OF PROPERTY LOCATED AT 4024 FANUEL STREET.

WHEREAS, The City of San Diego has the opportunity to purchase certain property currently in private ownership consisting of approximately 49,163 square feet, which property abuts Crescent Beach; and

WHEREAS, it is proposed that said property be acquired for parking and other public purposes; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


1. That pursuant to Section 2, subsection 23 of the annual appropriation ordinance, the Capital Improvements Program as contained in Document No. 754397, as amended, be and the same is hereby further amended by adding CIP Project No. 29-351, Acquisition of Property Located at 4024 Fanuel Street, to the fiscal year 1977 CIP Program.

2. That the Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$605,000 from the 245 Fund CIP Project No. 90-245.2, to Fund 244, CIP Project No. 29-351, Acquisition of Property Located at 4024 Fanuel Street, to provide funds for said property acquisition.

3. That the City Manager or his representative is hereby authorized to bid for the above described property.

4. That the City Auditor and Comptroller is hereby authorized to issue a check in the amount of \$60,500 from Fund 244, CIP Project No. 29-351, to be used as a deposit for the acquisition of the above described property.
