WHEREAS, The City of San Diego, as an eligible applicant for federal financing to construct public capital improvements under Title I of the Public Works Employment Act of 1976, has submitted forty-six (46) applications to the Economic Development Administration (EDA), U. S. Department of Commerce, with a combined requested value in excess of \$43 million; and

WHEREAS, time has been of the essence in the processing of said applications for capital improvement projects because of a 90-day on-site labor requirement and an exceptionally short application period; and

WHEREAS, during the months of September and October, 1976, participating and involved City employees and departments have had to regularly work numerous evenings and weekends over and above normal scheduled employment hours to complete the applications involved in a timely fashion; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council does commend those employees and departments, both nonmanagerial and managerial, who so selflessly gave of their time and energies to ensure the applications for federal funding were completed in a timely and professional manner and does hereby publicly express on behalf of the citizens of San Diego a debt of gratitude to the City staff involved.
