APPROVING MAP OF PALM VIEW SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by OWEN C. LEMONS, a Registered Civil Engineer, entitled "PALM VIEW Being a subdivision of the east half of Northeast Quarter of the Northwest Quarter of the Northwest Quarter of Section 27, T 18 S, R 2 W, SBM in the City of San Diego, County of San Diego, State of California, together with a portion of Palm Avenue as dedicated to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Beejay Drive and Santa Christina Court for public purposes; and said streets are hereby declared to be public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities as granted and shown on said map and subject to the conditions set forth thereon.


The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council,
