That Change Order No. 11, dated July 30, 1976, heretofore filed in the office of the City Clerk as Document No. 757227, issued in connection with the contract between The City of San Diego and Gentry-Rados, a joint venture, for the CONSTRUCTION OF SEDIMENTATION BASINS 5 & 6 - PT. LOMA WASTEWATER TREATMENT PLANT, said contract having been filed in the office of the City Clerk as Document No. 748599, be and the same is hereby approved; and the changes therein set forth, amounting to a net increase in the contract price of \$46,646.00, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to transfer within the Sewer Revenue Fund 506 the sum of \$160,345 from Unallocated Reserve (69.97) to C.I.P. City Force and Contract (62.19) solely and exclusively for this purpose and related costs.
