WHEREAS, there were relinquished to The City of San Diego certain abutter's rights of access in and to Iris Street, together with an easement for sewer purposes, affecting a portion of Lots 7 and 8 of Iris Gardens according to Map thereof No. 7185, filed in the office of the County Recorder of San Diego County; and

WHEREAS, the Engineering and Development Department has requested that the City revest those abutter's rights of access, together with the sewer easement, to McKEON CONSTRUCTION COMPANY, a California corporation, to allow better utilization of the land; and

WHEREAS, said easement and abutter's rights of access are no longer needed by the City and should be revested in the property; and

WHEREAS, it has been determined that all affected City departments have no objection to the revestment of said property rights; and

WHEREAS, the City desires to negotiate the sale of said property rights to McKeon Construction Company, under the provisions of Section 22.0902 (e) of the San Diego Municipal Code, which permits the sale of real property belonging to The City of San Diego by negotiation; and

WHEREAS, the sale of such an interest in real property as this may reasonably be accomplished only by negotiation; and

WHEREAS, the value of the property rights sought, as determined by a staff appraiser of said City, is the sum of One Hundred Thirty Dollars (\$130); and

WHEREAS, no real estate broker's commission shall be paid; and WHEREAS, the sale of the aforementioned property right is consistent with the public interest; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- That those certain real property rights described in that form of quitclaim deed on file in the office of the City 757237, be, and the same is hereby Clerk as Document No. authorized to be sold by negotiation for the sum of One Hundred Thirty Dollars (\$130) to McKEON CONSTRUCTION COMPANY, a California corporation.
- That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a guitclaim deed, the form of which is on file in the office of the City Clerk as Document 757237 , quitclaiming to McKEON CONSTRUCTION COMPANY, a California corporation, those certain property rights affecting a portion of Lots 7 and 8 of Iris Gardens, as more particularly described in said form of quitclaim deed.
- That no broker's commission shall be paid by City on the herein-described negotiated sale.
- That the City Clerk is hereby authorized and directed to file said deed and a certified copy of this resolution for record in the office of the San Diego County Recorder.
