| SOPHIA C. VIDMAR - | Human Resources | \$50 | Sophia Vidmar is an Intermediate Stenographer in the Community Services Programs section. She suggested a change in a filing system that is expected to save \$1,433 per year in finding removed files. This is a partial award pending a final twelve-month review. |
| BRUCE J. ERO - | General Services | \$15 | Bruce Ero is an Apprentice Carpenter in the Building Division. He noted that a fire door at Chollas would not close because one of the mechanisms operating the door was obstructed. His observation caused the door to be fixed and prevented tragedy in case of a fire. |
| RENATO S. LOPEZ - | Police | \$15 | Renato Lopez is a Motive Service Technician at the Police Garage. He suggested using water base paint to mark the tops of police vehicles for air identification rather than electrician's tape. This is expected to save \$150 per year in cleaning the vehicles. |
| DELBER C. CHIPMAN- | Engr. & Dev. | \$15 | Delber Chipman is a Surveyor II. A year ago he suggested that templates be made for standard traffic control loops. It has been discovered that an additional \$150 has been saved due to a greater number of signals installed during the review period. |
